- <u>Talkiatry</u> Provides virtual psychiatric care nationally for a range of mental health services, such as ADHD, anxiety, depression, and other care requiring medication management ensuring comprehensive support for members.

Nasal naloxone coverage expands July 1

In accordance with a Massachusetts law that took effect July 1, 2025, members can now receive a two-dose nasal naloxone pack using their **medical benefits**. You may dispense these two-dose packs to our members at the time of discharge or during a visit. Read more.
